Font: The body of the manuscript must be in "Times New Roman" Font only.

Font Size: 12 (Line spacing 1.5 & alignment "justify").

Footnotes: All footnotes must be in Font "Times New Roman", font size 10, single line spacing. All submissions must follow the "The Bluebook: A Uniform System of Citation (20th Edition)" / ILI.

The paper has to be original & less than 10% plagiarism.

All authors are requested to submit their papers through the google form or email at the ID provided in brochure.

Instructions for Poster Presentation (Offline)

Topic should be relevant to the theme of the conference.

Posters should be prepared in PORTRAIT format and in English/ Hindi only.
