2	All the NCETSGTU 2025 eligible students desirous of seeking admission to Basic B.Sc. Nursing Courses will have to attend physical counselling. The details of the counselling schedule shall be duly publicized on www.sgtuniversity.ac.in . The candidates are required to regularly visit the websites as stated above for updates.						
	The candidates will have to appear in person before the Admission Committee at SGT University, Gurugram for counselling, document verification & Fee deposition.						
3	Candidates applying on the basis of NCETSGTU 2025 should fulfill the eligibility criteria for being granted admissions as fixed by INC & SGT University.						
4	The candidates who have been declared eligible will have to appear in person for document verification (with all original documents) in front of Admission Committee SGT University, Gurugram. No appearance on behalf of candidates either through authority letter or by other means shall be acceptable. The NCETSGTU 2025 eligibility shall give NO legal right to the candidate for the said seat and the seat shall be confirmed only based on merit after document verification at the time of counselling. Similarly, deposition of tuition fee/any other fee shall NOT confer any legal right towards the eligible. The Admission Committee reserves the right to cancel the provisional allocation of seat allotted to a candidate in case of incomplete/invalid documents or by assigning reason to such a decision.

6 Eligibility Criteria:

a. Admission purely on the basis of merit in NCETSGTU 2025

- 1. The candidate must meet the following admission terms and conditions as prescribed by the Indian Nursing Council (INC), New Delhi.
 - I. The minimum age for admission shall be 17 years on 31st December of the year in which admission is sought. The maximum age limit for admission shall be 35 years.

II. Minimum Educational Qualification

- a. Candidate with Science who have passed the qualifying 12th Standard examination (10+2) and must have obtained a minimum of 45% marks in Physics, Chemistry and Biology taken together and passed in English individually.
- b. Candidates are also eligible from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government having Science subjects and English only.
- c. English is a compulsory subject in 10+2 for being eligible for admission to B.Sc. (Nursing).
- III. Colour blind candidates are eligible provided that colour corrective contact lens and spectacles are worn by such candidates.
- IV. Candidate shall be medically fit.
- V. 5. Married candidates are also eligible for admission.

- The Admission Committee will be responsible for taking decision for admission related matters like supervision of admission web-portal, conduct of counselling, document verification, allocation of seats, disputes thereof etc. in accordance with existing rules and regulations.

- The Registrar, SGT University, Haryana will be the Appellate Authority to hear the appeal for the decisions taken by the Admission Committee. Appeal can be sent on simple white paper with copy of decision of Admission Committee through email to registrar@sgtuniversity.org.
- 11 Fee structure:
 - Fee (Per Annum) Rs. 250000/- (Per Semester Rs. 125000/-)
 - Caution Money (One time) (Refundable) Rs. 10000/-
 - Alumni Fee (One time) (Non-refundable) Rs. 2500/-
 - Prospectus Charges Rs. 1500/-
 - Enrollments Fee Rs. 11000/- (One time) (Non-refundable)

The candidate will be required to pay fees and other charges through Damand Draft/Credit Card/Debit Card/ UPI Payment at the time of counselling for admission. The payment through cheque is not accepted.

Note: Hostel & Transport on request on applicable charges as per University norms.

- In case there is a vacancy after the first round of counselling due to any reason, such seats will be filled up during the second round of counselling.
 - (a) All the eligible candidates shall be allowed for participating in the second round.
 - (b) The allotment of the seats shall be made strictly as per merit prepared/drawn on the basis of merit of entrance test.

The seats remaining vacant even after the two rounds of counselling will be filled up via mop up/stray vacancies round of counselling.

13 TIE-BREAKER

For determination of the Inter-se-merit of candidates obtaining equal NCETSGTU 2025 marks:

In case two or more candidates obtain equal marks in the entrance examination, the inter-se-merit of such candidates will be determined in the order of preference as under:-

- i. The candidate with more marks in Biology at 10+2 shall be preferred. If the tie still persists;
- ii. The candidate with more marks in Chemistry at 10+2 shall be preferred. If the tie still persists;
- iii. The candidate with more marks in Physics at 10+2 shall be preferred. If the tie still persists;
- iv. An older candidate will be preferred over a younger candidate.
- 14 Date of commencement:

The course is scheduled to commence from 01 August 2025 or as notified by the University.

Last date of admission:

The last date for admission to the course is 30th September 2025 or as notified by the INC.

- 15 Fee Refund:
 - i. The candidates at the time of admission will be required to execute a bond with two sureties (on non-judicial stamp that he/she will not leave the course before completion **Annexure-I**
 - ii. In case of request for withdrawal of admission by a candidate before second round of counselling, the fee shall be refunded to the candidate as per the university norms.



- In case of request for withdrawal of admission by a candidate after the second round of counselling, the fee shall not be refundable to the candidate.
- Any candidate who leaves the course midway shall have to pay the entire course fee.

Foreign Nationals: -16

The entry qualification equivalency i.e., 12th standard will be obtained by UCG, New Delhi. The number of Seats shall be as per INC Notification No 8 of 2022 dated 05th May 2022 for Foreign Nationals.

General Instructions: -17

- a. List of documents to be brought at the time of counselling is at Annexure-II
- b. Admitted students shall pay the fees and other charges for all types of seats as per the fixed Fee and other charges fixed by the University from time to time
- c. All candidates belonging to the Scheduled Castes/Backward Classes/EWS/PWD/ESM/FF etc. must submit a certificate in the prescribed format issued from the competent authority of the State Government.
- d. Any candidate, if found to have submitted any false documents/claim benefit of reservation on the basis of false documents will be liable for penal action under Section 420, 120B of IPC and his/her candidature shall be cancelled immediately and shall be debarred for admissions in future.
- Any amendments by INC/University/State Government or any provisions contained in this 18 Notification shall have a binding on the candidate.

- 6) Proof of identification Aadhaar card / PAN Card / Driving license / Passport / Parivar Pehchan Patra /any other (any two).
- 7) Ten passport size photographs against white background
- 8. Parents two photo & Proof of identification Aadhaar card / PAN Card
- 9.) Undertaking /Bond from parents & candidate.
- 9.) Any other Document as required by Counselling Committee.
