2	<p>All the <b>NCETSGTU 2025 eligible students</b> desirous of seeking admission to Basic B.Sc. Nursing Courses will have to attend physical counselling. The details of the counselling schedule shall be duly publicized on <a href="http://www.sgtuniversity.ac.in">www.sgtuniversity.ac.in</a>. The candidates are required to regularly visit the websites as stated above for updates.</p> <p>The candidates will have to appear in person before the Admission Committee at SGT University, Gurugram for counselling, document verification &amp; Fee deposition.</p>															
3	Candidates applying on the basis of NCETSGTU 2025 should fulfill the eligibility criteria for being granted admissions as fixed by INC & SGT University.															
4	<p>The candidates who have been declared eligible will have to appear in person for document verification (<b>with all original documents</b>) in front of Admission Committee SGT University, Gurugram. No appearance on behalf of candidates either through authority letter or by other means shall be acceptable.</p> <p><b>The NCETSGTU 2025 eligibility shall give NO legal right to the candidate for the said seat and the seat shall be confirmed only based on merit after document verification at the time of counselling. Similarly, deposition of tuition fee/any other fee shall NOT confer any legal right towards the eligible. The Admission Committee reserves the right to cancel the provisional allocation of seat allotted to a candidate in case of incomplete/invalid documents or by assigning reason to such a decision.</b></p>

The candidate must meet the following admission terms and conditions as prescribed by the Indian Nursing Council (INC), New Delhi.</p> <p>I. The minimum age for admission shall be 17 years on 31st December of the year in which admission is sought. The maximum age limit for admission shall be 35 years.</p> <p><b>II. Minimum Educational Qualification</b></p> <p>a. Candidate with Science who have passed the qualifying 12th Standard examination (10+2) and must have obtained a minimum of 45% marks in Physics, Chemistry and Biology taken together and passed in English individually.</p> <p>b. Candidates are also eligible from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government having Science subjects and English only.</p> <p>c. English is a compulsory subject in 10+2 for being eligible for admission to B.Sc. (Nursing).</p> <p>III. 
